**Sunday morning**: 13 and over – warm-up 8:00am – start 9:00am **Sunday afternoon**: 9-10 and 11-12 – warm-up 1:00pm – start 2:00pm

**FORMAT:** All events will be held as timed finals – All events will be deck seeded

**ELIGIBILITY:** Open to all USA Swimming/Metropolitan Swimming Inc. registered swimmers.

All swimmers participating in this meet must be registered by the first day of the meet.

**Age on October 10, 2015** will determine age for the entire meet.

DISABILITY SWIMMERS:

Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special consideration. The athlete (or the athlete's coach) is also responsible for notifying the meet referee of any

disability prior to the competition.

ENTRIES: Swimmers are limited to 4 events per session. All sessions MAY be limited to 3 hours before scratches.

Payment must be received by Saturday, October 10, 2015.

**WARM-UP:** Lane assignment will be given at the meet. <u>First 35 minutes</u> will be general warm-up. <u>Last 20 minutes</u>:

2 or more lanes will be open for one-way sprint. All other lanes will remain open for general warm-up.

**SCRATCHES:** Coaches will be given scratch sheets upon check-in for each session. All scratches are due no later than 30

minutes prior to the start of the session. Coaches are asked to indicate clearly individual events scratches

and which swimmers will not be participating in the session.

**COACHES:** In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA

Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not

possess these credentials will be required to leave the deck area.

#### From Taconic Parkway South:

Take exit for route 133, Mount Kisco. At traffic light, make a right turn. At next traffic light, turn right and follow signs for Mt. Kisco (on route 133 east). Drive approximately 4 miles. At the end of 133, turn right onto route 117 South (Main Street). Pass 2 traffic lights. Just after the third traffic light, make an immediate left turn into the B/G Club driveway..
