- FORMAT:** All events are timed finals. Deck seeding will be used.
- ELIGIBILITY:** Open to all USA Swimming/Metropolitan Swimming Inc. registered swimmers. All swimmers participating in this meet must be registered by the first day of the meet. **Age on May 28 will determine age for the entire meet.**
- DISABILITY SWIMMERS:** Swimmers with disabilities are encouraged to attend. Contact the meet director if you need special consideration. The athlete (or the athlete's coach) is also responsible for notifying the meet referee of any disability prior to the competition.
- ENTRIES:** Swimmers will be limited to **three (3) events per day**. Entries are limited and will be on a first come, first served basis. Entries should be submitted in Hy-Tek Meet Manager form.

- DEADLINE:**
1. Metro LSC teams will be given priority on a first come, first served basis. Metro team entries must be received by **May 11, 2016**.
 2. The final entry deadline for this meet is **May 18, 2016**.
 3. Metro entries received between **May 11, 2016** and **May 18, 2016** and all entries from other LSCs will be entered in the order they were received, as space allows.
- An entry receipt confirmation will be emailed if you provide an email contact. **Please contact the Meet Director if you do not receive such a report within two days of your original email.**
- ENTRY FEE:** An entry fee of **\$5.00** per individual event must accompany the entries. Make check payable to: [Asphalt Green](#). Payment must be received by **May 28, 2016** for email entries. Payment must be included with all mail entries. Failure to pay entry fees by this deadline could result in teams being barred from the meet.
- WARM-UP:** General warm-up with feet-first entry only. Doors for all coaches, athletes and spectators will open **30 minutes** prior to warm-up. Sprint Lanes will be designated 20 minutes prior to the start of the session.
- SCRATCHES:** **Coaches, please note that a final scratch file will be due May 27 at 9 AM for Saturday's events, and we will have scratch sheets for Sunday due at the end of the Saturday PM session.**
- SEEDING:** Long Course Times Only.
The 12 & Under events will use super seeding the event will be swum together, but scored separately with the

fastest heat of each age group being swum together.

- COACHES:** In accordance with Metropolitan Swimming Inc. Policy, only those coaches who display current, valid USA Swimming credentials will be permitted to act in a coaching capacity at this meet. Coaches who do not possess these credentials will be required to leave the deck area.
- AWARDS:** Ribbons 1st—8th place for 12 & Under age groups. All awards will be distributed to coaches only at the end of the meet. No individual awards will be distributed. Awards will not be mailed or forwarded, except in the case of computer failure.

- SAFETY:** Metropolitan safety and warm-up procedures will be in effect. Marshals will be present throughout warm-ups and competition, and have the authority to remove, with the concurrence of the meet Referee, any swimmer, coach, club, or spectator for failure to follow the safety rules.
- AUDIO/VISUAL:** The use of audio or visual recording devices, including a cell phone or tablet device is not permitted in changing areas, restrooms, locker rooms or behind the blocks.
- DISCLAIMER:** Upon acceptance of his/her entries, the participant waives all claims against **Asphalt Green, AGUA Swim Team, Metropolitan Swimming Inc., USA Swimming Inc.,** their agents or representatives for any injury incurred as a result of this meet.
- LOCKER ROOMS:** Deck changes are prohibited.
