**May 2015 House of Delegates: "By the start of the 2017-18 short course season, Metro teams wishing to host meets must have a minimum of 4 certified officials affiliated with their teams: a meet referee, a starter, and two or more stroke & turns judges. Teams that do not meet this minimum number of officials will not be granted sanctions". Amendment: The requirement to have a referee and starter shall be waived if a club has at least 4 (four) Strokes & Turns (S&T) officials affiliated (registered) with the host club. As amended in the May 2017 HOD meeting.**
